Job Description

Position Summary:

Applicant for this position is a 1099 Independent Contractor who provides Outpatient Mental Health services to adults and adolescents. Duties include assessing, monitoring, advocating on behalf of, and linking clients to community resources. Services are provided to clients who meet Medicaid or state criteria for case management.

Required Knowledge and Abilities:

- Applicant must have applicable knowledge of Medicaid rules for Targeted Case Management service delivery when providing services to Medicaid enrolled clients;
- Must have knowledge of and apply recovery-based principles and practices in service delivery that includes addressing and documenting the client's needs, strengths, abilities, barriers and preferences;
- Must be knowledgeable of community resources;
- Must be able to work with individuals who have a mental health disability;
- Applicant must have or obtain the provisional **CBHCM certification** provided by the Florida Certification Board within three months of initially providing Medicaid services;
- Must be reliable and a team player;
- Ability to provide Services may be provided in the client's home, or in other community settings;
- Ability to attend virtual team meetings, supervision meetings, and trainings according to agency needs; applicant must have equipment to perform job duties and a stable internet connection;
- Has knowledge of psychiatric diagnosis and ability to recognize signs and/or symptoms of psychiatric illness.

Required Skills:

- Problem Solving Identifies and resolves problems time efficiently; Gathers and analyzes information; Develops solutions; Works well in group problem-solving situations; Uses logic and reasoning.
- Oral Communication Speaks clearly and persuasively; Listens and gains clarification when necessary;
 Accurately responds to client questions and concerns as needed; Demonstrates presentation skills;
 Participates in meetings.

- Written Communication Writes clearly and concisely; Tailor's writing style to meet specific needs; Able to read and interpret written information.

Qualifications and Education Requirements:

- One year of Full-Time or equivalent experience providing targeted case management services to adults experiencing serious mental illness and/or children with emotional disturbances;
- Has completed or the provisional CBHCM certification provided by the Florida Certification Board within three months of initially providing Medicaid services;
- Has knowledge of available resources within service area(s);
